### 1) Consent Agreement - Medical Release – Waiver/Release of Liability

I, Participant/Guardian, acknowledge and fully understand that LBC Judo "Activity" includes physical contact exercises and that participation involves engaging in activities that may result in serious personal injury, including death, emotional injury, and property damage, and possibly resulting financial loss, due not only to my own actions, inactions and/or negligence, but also to that of others. Further, I acknowledge that there may be risks not known to me and/or not reasonably foreseeable. Participant/Guardian assumes all risks resulting from participation in LBC Judo martial arts. Participant/Guardian further enters into all sessions, classes, demonstrations, training, and competitions at or away from Lizella Baptist Church entirely of their own free will, understanding the importance of following rules established by LBC Judo instructors, senior members, coaches, and other officials, and hereby agrees to follow those rules.

Participant/Guardian certifies Participant to be in good physical condition, having no disease, injury, or other condition that would impair Participant's performance or mental well-being by intense physical practice and training, or do harm to, injure or threaten the physical/mental well-being of others.

In consideration of the opportunity to participate in the activity described above (the "Activity"), the Participant (or parent/guardian if Participant is a minor) acknowledges and accepts the risks of injury associated with participation in and transportation to/from the Activity. The Participant (or parent/guardian) grants permission in case of injury to LBC Judo, its senior members, instructors, coaches, trainers and all medical professionals present or requested by LBC Judo to provide medical assistance and/or treatment for such injury. Participant/Guardian accepts personal financial responsibility for any injury or other loss sustained during the Activity or during transportation to and from the activity, as well as for any medical treatment rendered to the Participant that is authorized by the Sponsor or its agents, employees, volunteers, or any other representatives (collectively referred to hereinafter as the "Activity Sponsor"). Further, the Participant (or parent/guardian) releases and promises to indemnify, defend, and hold harmless LBC Judo/the Activity Sponsor for any injury arising directly or indirectly out of the described Activity or transportation to and from the Activity, whether such injury arises out of the negligence of the Activity Sponsor/volunteers/representatives, the Participant, other Participants, or otherwise.

Acknowledging martial arts are potentially dangerous and could result in the serious injury, including death, to myself and/or others, Participant/Guardian hereby forever releases, waives, discharges and covenants not to sue Lizella Baptist Church, its staff, Judo leaders, members, volunteers, coaches, other Judo event staff, other participating martial arts organizations, affiliated clubs/academies, volunteers, medical personnel, other participants, their parents and/or guardians, instructors, sponsoring agencies, or any other individuals and/or entities, for any and all injuries, including death and damage(s) incurred while in, entering, or leaving the premises or while participating in: practices, demonstrations, training, and competitions at or away from the premises. I further agree to indemnify and hold Sponsor, Lizella Baptist Church/LBC Judo, its principals, instructors/supervisors, and any other member harmless from and against any and all claims, liabilities, and damages which may result from my use of the martial arts techniques or someone else's use of the martial arts techniques upon me.



If a dispute over this agreement or any claim for damages arises, the Participant (or parent/guardian) agrees to resolve the matter through a mutually acceptable alternative dispute resolution process. If the Participant (or parent/guardian) and the Activity Sponsor cannot agree upon such a process, the dispute will be submitted to a three-member arbitration panel for resolution pursuant to the rules of the American Arbitration Association.

I hereby give full permission to Lizella Baptist Church, its staff, representatives and volunteers to obtain medical care from any licensed physician, hospital or medical clinic. I accept complete responsibility and agree to pay for any and all associated fees or charges, holding the Activity Sponsor and all instructors, volunteers and participants harmless and free of any liability for charges or claims arising from injury or loss resulting from participation in this activity.

Further, having been informed of the intentions of the Sponsor to provide fitness activities & equipment, I assume all risks and hazards incidental to the conduct of the activity and do hereby release, absolve, indemnify, and hold harmless Lizella Baptist Church, its staff and judo instructors for injuries resulting from my/my child's participation. In case of injury, I hereby waive all claims against the Sponsor, organizers, property owners, coordinators, instructors, supervisors and volunteers. I understand that damage to fitness equipment or facilities by Participant shall be the responsibility of Participant/Guardian. I agree, prior to participating in LBC Judo at the current location or LBC Judo events away from the current premises, that I am responsible to inspect the mats, equipment, facilities and if I believe anything to be unsafe or beyond my capability, will immediately advise the senior member/instructor of such condition(s) and refuse to participate until said hazard is removed, resolved/repaired.

I, as Participant/Guardian (if Participant is of minor age as defined by state and local laws), do hereby agree to all conditions set forth above and accept their ramifications, and I additionally confirm and agree to all of the above statements, conditions, waivers, releases, indemnifications, and consent to participate under the above conditions. In case of a minor: I/We the parent(s), or legal guardian(s) of this minor have instructed the minor of the provisions hereof and their ramifications and hereby consent to this minor's participation. I/We additionally confirm and agree to all and adopt and ratify, as my/our own all the rules, regulations, representations, waivers, releases, indemnities, etc., included herein.
